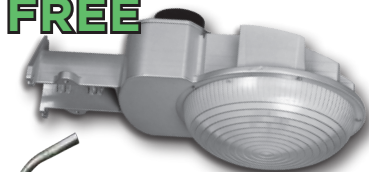



Mini-Split New System Requirements

- ① Rebate must be signed over to EZ Energy Save
- ② Pictures need to be taken of old equipment & name plate
- ③ Pictures need to be taken of the new equipment once they are installed
- ④ Copy of most recent utility bill and must be provided with order
- ⑤ New equipment must be installed within 45 days

FAQ

Q: Why are there free products?

A: Utility companies pay for lighting & mini-splits to meet energy reduction & decarbonization goals.

Q: How we get paid?

A: We are paid by your electric utility.

Q: How long to install?

A: You have up to 45 days to install your new lights or mini-split units. 10% of all lighting jobs will be inspected.

Q: Can you install it yourselves?

A: You are allowed to self install lighting as long as your local municipality permits it.

*Mini-splits must be installed by licensed HVAC technician.

Q: How long is shipping?

A: Ships in 1-2 weeks.

Q: How many times can you order?

A: You can order multiple times.

Q: What do I need to provide to take advantage of these programs?

A: We do need a copy of your electric bill and tax exempt form (if applicable)

Q: How to order?

A: Call, email or text your order.
